

COMMUNITY CLEANUP BIN RESTRICTIONS

1. **Bins are overnight only. Bin will be automatically picked up as early as 6:00 a.m. the next business day. There will be a charge of \$139.00 assessed for any container not accessible on the scheduled day of pick-up.**
2. **Bin lid MUST close. Do not load over the top of the bin.** Bin must be level. A charge will apply to offload any bins to correct overloading. Additional charge will also apply for any special handling required. Min chg \$69.50 (½ hr rate)
3. **Dirt, sod, cement, rock, tile, bricks and asphalt ARE NOT ALLOWED in the bin.**
4. Composition roofing material is **NOT ALLOWED**.
5. **The customer shall observe the following bin restrictions:**
 - No hazardous waste – oil, paint, solvents, etc.
 - No 50-55 gallon containers
 - No excessively heavy items – use common sense
 - No dead animals or tree stumps
 - No refrigerators, freezers or air conditioners
 - No car bodies, engines or transmissions
 - No items over 3 ft in length
 - No tires allowed
 - No mercury thermostats or thermometers
 - No washing machines or dryers
 - No household batteries, cell phones or car batteries
 - No televisions, computer monitors or other equipment with cathode ray tubes.
 - No fluorescent lamps, CFL's or sodium vapor lamps
 - No mattresses

Customer will be charged if any of the above items are found in bin

6. All containers will be placed curbside only. Containers are not allowed in alleys.
7. Customer is solely responsible for materials in bin.
8. Appliances are not allowed in the bin and may be picked up for an additional charge. Please call to schedule.

HOLD HARMLESS AGREEMENT FOR PLACEMENT OF RENTAL CONTAINER

Customer shall assume the defense of and indemnify and save harmless City of Manteca, City's agents and employees, from all claims, liability, loss, damage and injury of every kind, nature, and description, directly or indirectly resulting from the placement of City furnished rental container on private property. Customer shall also be responsible for any and all damage to City property, including without limitation bins themselves or City Vehicles, for Customer's failure to comply with the requirements in Paragraphs 1 through 7 above or any other applicable rules and regulations pursuant to the Manteca Municipal Code or California law.
